On **February 10, 2014**, **Owen Edwards** – see receipt (with Irwin Nanda-best friends & roommates) ordered and printed an **extra 2200 ballots** from the same printing house for **\$994.40** (and billed it to our union – to add insult to injury, we the members paid for the cheating!). The printing company's name has been blacked out on these receipts, as they had really nothing to do with it as they did what the **Election Committee Chair OWEN EDWARD's** (IRWIN'S best friend –who lives with him) asked them to do.

In **Round 2** they did the same thing., but they did not make a separate transaction...it was all on the same bill. See round 2 receipt) they ordered **6000 more ballots** that the envelopes going out to the members.

IRWIN'S followers include:

Robby Jouhal, Sanjay Sapra, Mandeep Kalra, Walter Woloschuk, Owen Edwards (who was the election chair), **Pam Taschuk** (was on the election committee) **Pavneet Ver, Gurmeet Dhillon** and others...).
